**Other hazards which do not result in classification** Titanium dioxide is classified by IARC as a Group 2B carcinogen, meaning there is inadequate evidence in humans for the carcinogenicity of titanium dioxide, but there is sufficient evidence in experimental animals for the carcinogenicity of titanium dioxide. Titanium dioxide in this preparation, due to its bound form, does not present this carcinogenic risk. None of the other ingredients in this preparation are classified as carcinogens according to ACGIH, EU, IARC, MAK, NTP or OSHA.

## 4. First-aid measures

**Skin corrosion/irritation** Based on available data, the classification criteria are not met. Not a known irritant. (OECD 404).

**Serious eye damage/eye irritation** Based on available data, the classification criteria are not met. Not a known irritant. (OECD 405).

### Respiratory or skin sensitization

<b>Skin sensitization</b>	This product is not expected to cause skin sensitization.

**Germ cell mutagenicity** Based on available data, the classification criteria are not met. Negative Ames Test (Test strains: Salmonella typhimurium).

**Carcinogenicity** Based on available data, the classification criteria are not met.

Titanium dioxide is classified by the IARC as a Group 2B carcinogen (the substance is possibly carcinogenic to humans). The IARC classification was based on high concentrations of titanium dioxide particles in animal lungs. Under intended use of this toner product, exposure to titanium dioxide is much lower.

None of the other ingredients in this preparation are classified as carcinogens according to ACGIH, EU, IARC, MAK, NTP or OSHA.

**Specific target organ toxicity - repeated exposure** Based on available data, the classification criteria are not met.

**Aspiration hazard** Based on available data, the classification criteria are not met.

**Further information** Complete toxicity data are not available for this specific formulation. Refer to Section 2 for potential health effects and Section 4 for first aid measures.

In a study in rats (H.Muhle) by chronic inhalation exposure to a typical toner, a mild to moderate degree of lung fibrosis was observed in 92% of the rats in the concentration (16mg/m<sup>3</sup>) exposure group, and a minimal to mild degree of fibrosis was noted in 22% of the animals in the middle (4mg/m<sup>3</sup>) exposure group. But no pulmonary changes were reported in the lowest (1mg/m<sup>3</sup>) exposure group, the most relevant level to potential human exposures.

**Ecotoxicity** The product is not classified as environmentally hazardous. However, this does not exclude the possibility that large or frequent spills can have a harmful or damaging effect on the environment.
