Other hazards which do not result in classification Titanium dioxide is classified by IARC as a Group 2B carcinogen, meaning there is inadequate evidence in humans for the carcinogenicity of titanium dioxide, but there is sufficient evidence in experimental animals for the carcinogenicity of titanium dioxide. Titanium dioxide in this preparation, due to its bound form, does not present this carcinogenic risk. None of the other ingredients in this preparation are classified as carcinogens according to ACGIH, EU, IARC, MAK, NTP or OSHA.

4. First-aid measures

Titanium dioxide is classified by the IARC as a Group 2B carcinogen (the substance is possibly carcinogenic to humans). The IARC classification was based on high concentrations of titanium dioxide particles in animal lungs. Under intended use of this toner product, exposure to titanium dioxide is much lower.

None of the other ingredients in this preparation are classified as carcinogens according to ACGIH, EU, IARC, MAK, NTP or OSHA.

In a study in rats (H.Muhle) by chronic inhalation exposure to a typical toner, a mild to moderate degree of lung fibrosis was observed in 92% of the rats in the concentration (16mg/m³) exposure group, and a minimal to mild degree of fibrosis was noted in 22% of the animals in the middle (4mg/m³) exposure group. But no pulmonary changes were reported in the lowest (1mg/m³) exposure group, the most relevant level to potential human exposures.
