2.3. Other hazards

This preparation contains no component classified as Persistent, Bioaccumulative, and Toxic (PBT) or very Persistent and very Bioaccumulative (vPvB) as defined under Regulation (EC) 1907/2006.

Carbon black is classified by the IARC as a Group 2B carcinogen (the substance is possibly carcinogenic to humans). Carbon black in this preparation, due to its bound form, does not present this carcinogenic risk.

Titanium dioxide is classified by IARC as a Group 2B carcinogen, meaning there is inadequate evidence in humans for the carcinogenicity of titanium dioxide, but there is sufficient evidence in experimental animals for the carcinogenicity of titanium dioxide. Titanium dioxide in this preparation, due to its bound form, does not present this carcinogenic risk.

None of the other ingredients in this preparation are classified as carcinogens according to ACGIH, EU, IARC, MAK, NTP or OSHA.

11.1. Information on toxicological effects

Acute toxicity Based on available data, the classification criteria are not met. LD50/oral/rat >5000 mg/kg.

Skin corrosion/irritation Based on available data, the classification criteria are not met. Not a known irritant. (OECD 404).

Serious eye damage/eye irritation Based on available data, the classification criteria are not met. Not a known irritant. (OECD 405).

Respiratory sensitization Not a respiratory sensitizer.

Skin sensitization This product is not expected to cause skin sensitization.

Germ cell mutagenicity Based on available data, the classification criteria are not met. Negative Ames Test (Test strains: Salmonella typhimurium).

Carcinogenicity	Based on available data, the classification criteria are not met. Carbon black is classified as a carcinogen by the IARC (possibly carcinogenic to humans, Group 2B) and by the State of California under Proposition 65. In their evaluations of carbon black, both organizations indicate that exposure to carbon black, per se, does not occur when it remains bound within a product matrix, specifically, rubber, ink, or paint. Carbon black is present only in a bound form in this preparation. Titanium dioxide is classified by the IARC as a Group 2B carcinogen (the substance is possibly carcinogenic to humans). The IARC classification was based on high concentrations of titanium dioxide particles in animal lungs. Under intended use of this toner product, exposure to titanium dioxide is much lower. None of the other ingredients in this preparation are classified as carcinogens according to ACGIH, EU, IARC, MAK, NTP or OSHA.

Other information	Complete toxicity data are not available for this specific formulation Refer to Section 2 for potential health effects and Section 4 for first aid measures. In a study in rats (H.Muhle) by chronic inhalation exposure to a typical toner, a mild to moderate degree of lung fibrosis was observed in 92% of the rats in the concentration(16mg/m3) exposure group, and a minimal to mild degree of fibrosis was noted in 22% of the animals in the middle (4mg/m3) exposure group. But no pulmonary changes was reported in the lowest (1mg/m3) exposure group, the most relevant level to potential human exposures. In 1996, the IARC reevaluated carbon black as a GROUP 2B carcinogen (possible human carcinogen). This evaluation is given to carbon black for which there is inadequate human evidence, but sufficient animal evidence. The latter is based upon the developer of lung tumors in rat receiving chronic inhalation exposures to free carbon black at level that induce particle overload of the lung. Studies performed in animal models other than rats have not demonstrated an association between carbon black and lung tumors. Moreover, a two-year cancer bioassay using a typical toner preparation containing carbon black demonstrated no association between toner exposure and tumor development in rats.
