##### Description of necessary first aid measures

Collect dust using a vacuum cleaner equipped with HEPA filter. The product is immiscible with water and will spread on the water surface. Stop the flow of material, if this is without risk. Sweep up or vacuum up spillage and collect in suitable container for disposal.
<b>Other issues relating to spills and releases</b>	Fine powder can form explosive dust-air mixtures. Take up mechanically and collect in suitable container for disposal. Dispose of in compliance with federal, state, and local regulations.

In a study in rats (H.Muhle) by chronic inhalation exposure to a typical toner, a mild to moderate degree of lung fibrosis was observed in 92% of the rats in the concentration(16mg/m3) exposure group, and a minimal to mild degree of fibrosis was noted in 22% of the animals in the middle (4mg/m3) exposure group. But no pulmonary changes was reported in the lowest (1mg/m3) exposure group, the most relevant level to potential human exposures.
