### 2.3. Other hazards

Potential routes of exposure to this product are skin and eye contact, ingestion, and inhalation. Carbon black is classified by the IARC as a Group 2B carcinogen (the substance is possibly carcinogenic to humans). Carbon black in this preparation, due to its bound form, does not present this carcinogenic risk. Complete toxicity data are not available for this specific formulation.
