**2.3 Other hazards which do not result in GHS classification** Carbon black is classified by the IARC as a Group 2B carcinogen (the substance is possibly carcinogenic to humans). Carbon black in this preparation, due to its bound form, does not present this carcinogenic risk. None of the other ingredients in this preparation are classified as carcinogens according to ACGIH, EU, IARC, MAK, NTP or OSHA.

## 4. First-aid measures

### 4.1 Description of first-aid measures

**Inhalation** Move person to fresh air immediately. If irritation persists, consult a physician.

## 5. Fire-fighting measures

### 5.1 Prohibited extinguishing media and suitable extinguishing media

## 6. Accidental release measures

**6.1 Personal precautions, protective equipment and emergency procedures** Keep unnecessary personnel away. Wear appropriate protective equipment and clothing during clean-up. **6.2 Environmental precautions** Avoid discharge into drains, water courses or onto the ground.

**6.3 Methods and materials for containment and cleaning up** Avoid the generation of dusts during clean-up. Use explosion proof electric equipment. Collect dust using a vacuum cleaner equipped with HEPA filter. The product is immiscible with water and will spread on the water surface. Stop the flow of material, if this is without risk. Sweep up or vacuum up spillage and collect in suitable container for disposal.

**Other issues relating to spills and releases** Fine powder can form explosive dust-air mixtures. Take up mechanically and collect in suitable container for disposal. Dispose of in compliance with federal, state, and local regulations.

## 7. Handling and storage

**7.1 Precautions for safe handling, use and storage** Minimize dust generation and accumulation. Use local exhaust ventilation. Avoid prolonged exposure. Practice good housekeeping.

**7.2 Conditions for safe storage, including any incompatibilities** Store in tightly closed original container. Store in a well-ventilated place. Store away from incompatible materials (see Section 10 of the SDS).

Complete toxicity data are not available for this specific formulation

In a study in rats (H.Muhle) by chronic inhalation exposure to a typical toner, a mild to moderate degree of lung fibrosis was observed in 92% of the rats in the concentration(16mg/m<sup>3</sup>) exposure group, and a minimal to mild degree of fibrosis was noted in 22% of the animals in the middle (4mg/m<sup>3</sup>) exposure group. But no pulmonary changes was reported in the lowest (1mg/m<sup>3</sup>) exposure group, the most relevant level to potential human exposures.

In 1996, the IARC reevaluated carbon black as a GROUP 2B carcinogen (possible human carcinogen). This evaluation is given to carbon black for which there is inadequate human evidence, but sufficient animal evidence. The latter is based upon the developer of lung tumors in rat receiving chronic inhalation exposures to free carbon black at level that induce particle overload of the lung. Studies performed in animal models other than rats have not demonstrated an association between carbon black and lung tumors. Moreover, a two-year cancer bioassay using a typical toner preparation containing carbon black demonstrated no association between toner exposure and tumor development in rats.
