**6.3. Methods and materials for containment and cleaning up** Avoid the generation of dusts during clean-up. Use explosion proof electric equipment. Collect dust using a vacuum cleaner equipped with HEPA filter. The product is immiscible with water and will spread on the water surface. Stop the flow of material, if this is without risk.
