Carbon black in this preparation, due to its bound form, does not present this carcinogenic risk. 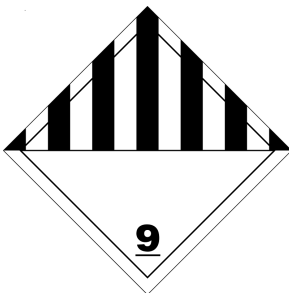

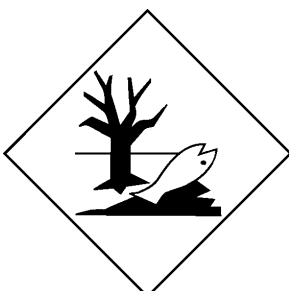
