Carbon black is classified by the IARC as a Group 2B carcinogen (the substance is possibly carcinogenic to humans). Carbon black in this preparation, due to its bound form, does not present this carcinogenic risk. ### Additional information on product composition

In section 2 of the SDS as well as on the label, the classification of the mixture is provided.
