## 2.3. Other hazards

The classification of this mixture as a reproductive category 2 (H361) is based on the harmonized classification of diphenyl(2,4,6-trimethylbenzoyl)phosphine oxide as mentioned in Annex VI of Regulation (EC) No.1272/2008.

Recent test data for diphenyl(2,4,6-trimethylbenzoyl)phosphine oxide presented on the EU REACH Dossier suggest that classification as reproductive category 1B (H360) is more suitable. This would lead to mixture classification of the product as reproductive category 1B (H360).

The lead registrant has updated the REACH dossier and requested that the Swedish authority start the process of amending the harmonized classification. This SDS was updated according to guidance of the Swedish Chemicals Agency. Titanium dioxide is classified by IARC as a Group 2B carcinogen, meaning there is inadequate evidence in humans for the carcinogenicity of titanium dioxide, but there is sufficient evidence in experimental animals for the carcinogenicity of titanium dioxide. Exposure to titanium dioxide in this product is unlikely because it is a component of a liquid ink and is bound to other ink components.

Potential routes of exposure to this product are skin and eye contact, ingestion, and inhalation.

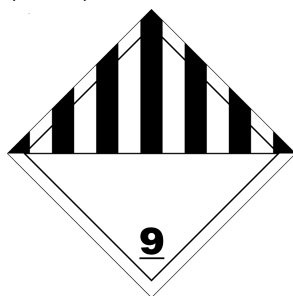

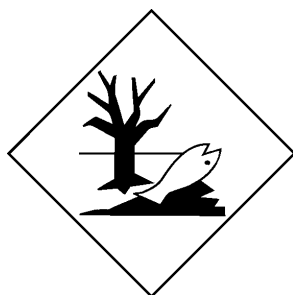
