Carbon black is present only in a bound form in this preparation.

2-pyrrolidone: This component showed developmental effects only at high doses that were toxic to pregnant test animals (OECD Testing Guideline 414: Prenatal Developmental Toxicity Study). ### Additional information on product composition

In section 2 of the SDS as well as on the label, the classification of the mixture is provided.

Most of the water based inks are "not classified".

The classification of the mixture is based on the individual ingredients and their concentration within the mixture.

All ingredients contributing to the classification are stated in Section 3 of the SDS.

Relevant limit values of ingredients on which the exposure assessment is based, are listed in section 8 of the SDS.
