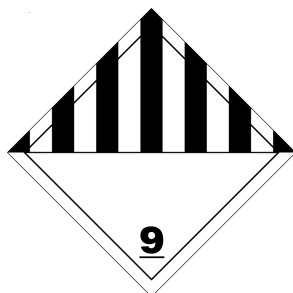

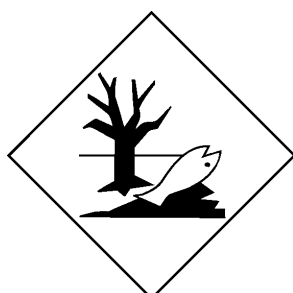

Relevant limit values of ingredients on which the exposure assessment is based, are listed in section 8 of the SDS.
