2.3. Other hazards

Carbon black is classified by the IARC as a Group 2B carcinogen (the substance is possibly carcinogenic to humans). Carbon black in this preparation, due to its bound form, does not present this carcinogenic risk. Relevant limit values of ingredients on which the exposure assessment is based, are listed in section 8 of the SDS.

The product may contain sensitizing ingredients that may cause allergic reaction to certain people.

Section 2 of the SDS states these ingredients where applicable.
