4. First aid measures

First aid procedures

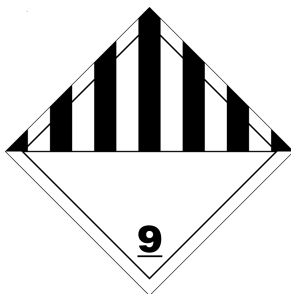

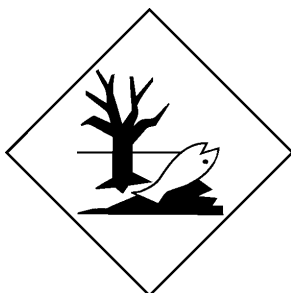
